### 2. RDS redesign

#### 2.1 Launch of RDS redesign

The redesigned Right Decision Service was launched on Thursday 23rd October. The RDS redesign has introduced major improvements in the search and browse functionality of the RDS, including:

- New NHS Scotland branding as agreed with Scottish Government
- Search now toggles between toolkit title and all content, rather than the confusing two search boxes which appeared previously
- Search now operates across a wider range of content (some document types were previously excluded) and the search algorithm has been refined.
- 'Favourite' key toolkits so you can return to them with one click (no need to search or browse or bookmark the URL in browser)
- Filter and sort search results with greater flexibility and specificity and can hide password-protected resources
- Search results (and browse) are categorised into 'All', 'National' and 'Patient/Public' tabs
- See publishing and review information for a wider range of content types
- Browse and filter search results by organisation (local NHS Board, HSCP, national), and by topic including condition/disease, service delivery, resource type, population group and staff group.

We have also introduced the capability to edit and localise shared content, so that content can be more easily reused and customised across local and national toolkits. And the other major functionality change that took place as part of the redesign - implementation of archiving and version control – was implemented some weeks ago.

### 3. RDS redesign training and orientation

#### 3.1 – Engaging health and social care staff in using the RDS – end-user training

The primary goal of the redesign is to make it easier and quicker for health and social care staff to find and use tools to support their day-to-day decisions. We would encourage you to circulate this <u>flyer</u> and the times below widely across your organisation to encourage users and current non-users to get the full benefit of the Right Decision Service. The end-user RDS redesign training and orientation sessions are scheduled for the following times:

As well as these training and orientation sessions, there will soon be further resources to support both editors and end-users with effectively using the redesigned RDS. These resources will include video tutorials and user guides.

# 4. Further RDS improvements

#### 4.1 Link-checker

Work on the new RDS link-checker reporting system was temporarily paused while all efforts focused on launch of the redesigned RDS. This has now resumed and we are awaiting confirmation of timescale from Tactuum – potentially end of November.

#### 4.2 Bugs and improvements

During November, improvements will be implemented to:

- Enable use of left-hand navigation in home nodes even when only one toolkit is included in the home node currently a single toolkit will revert to the tile format.
- Switch to use of Azure Front Door rather than Application Gateway to reduce risk of outages during indexing time and to address the limitation on assigning editors permission to edit large numbers of toolkits.
- Exclude linked toolkits from mobile app toolkit search.

#### 4.3 New feature requests

Now that the redesigned RDS is live, we are working with Tactuum to define requirements and to get estimates and timescales for new feature requests to be implemented by end of March 2026. The features selected will depend on cost and timescale. Among those we have asked to be costed as a priority are customisation of reviewer alerts at toolkit and organisation level, and creation of customisable HTML pathways as a more flexible alternative to the pathway builder tool format.

# 6. New RDS toolkits - live and in development

The following toolkits are in development:

- Excellence in Care Framework Development has begun on an Excellence in Care RDS toolkit, which will
  support NMAHP and other health and social care workers in delivering excellent care in their services.
  Excellence in Care is a national care assurance programme commissioned by the Scottish Government and
  delivered by Healthcare Improvement Scotland in response to the Vale of Leven Hospital Inquiry.
  It aims to:
  - o Promote high-quality, safe, effective, person-centred care
  - Integrate and coordinate care delivery across NHS Scotland
  - Foster a culture of continuous improvement and assurance
  - Support staff through the development of resources

The RDS toolkit will allow workers to easily access the framework and see how it can be applied to their work and services.

- <u>Vascular surgery pathways</u> This live CfSD toolkit is being updated. The Venous leg ulcer national pathway is being adapted to reflect a recent review. A new vascular pathway (Carotid Endarterectomy (CEA)) will be added. The updates on this toolkit should be complete by the end of 2025.
- Cancer prehabilitation Work has been taking place on professional and public toolkits. It is hoped that they will be ready to go live by the end of 2025.

The following National toolkit for patients and public recently went live:

• <u>Teenage and Young Adult Cancer Services</u> - This web and mobile toolkit provides access to age-appropriate information and resources for young people with cancer across Scotland, their families, friends and carers.

The following GGC toolkits for patients and public have also recently gone live:

- <u>KIDS for Families</u> The KIDS (Kids Independently Developing Skills) for Families toolkit helps families support their babies, children, and young people to live healthy lives and reach their full potential.
- <u>GGC BMT and Cellular Therapies</u> This toolkit gives information on the patient journey from pre-transplant through to the medical procedure and advice post-transplant.

# 7. Wider RDS developments

#### 7.1 RDS access to medicines advice

Work is continuing on improving access to and use of medicines information on the RDS. This is part of a large UK-wide government funded project to improve access to quality assured new medicines information including clinical and cost effectiveness. It involves close collaboration between the Right Decision Service, the SIGN team and Scottish Medicines Consortium within HIS, and with Public Health Scotland data and analytics colleagues.

Key aspects of this work include:

- Facilitating efficient, consistent and comprehensive access to medicines information on the RDS, for example
  through browsing standardised categories and hierarchies for conditions and medicines such as the BNF
  categories and the NHS dictionary of medicines and devices (dm+d) headings. We are also exploring creation
  of a personalised alerting service for new information on medicines and other clinical topics.
- Creation of a national platform on the RDS for the capture and use of Patient Reported Outcome and
  Experience Measures (PROMs and PREMs). This is a key deliverable within the Service Renewal Framework. It
  will provide real world information on personal outcomes relating to use of medicines, to complement the
  clinical and cost outcomes data already gathered. These PROMs and PREMs reports will inform personcentred and shared decision-making and service planning based on what matters to the person.
- Automatic conversion of SIGN guidelines created in Word templates into consistent RDS toolkit structures and design formats. We hope there will be potential to extend this automated Word to RDS conversion to other RDS guidelines and pathways in future.
- Integrating Scottish Medicines Consortium (SMC) advice into SIGN guideline toolkits and other guidelines and pathways

#### 7.2 Pharmacogenomics decision support

This European project is led by Scottish Government Effective Prescribing and Therapeutics Division, which has commissioned the Right Decision Service to implement decision support tools for polypharmacy and pharmacogenomics and for use in PROMS for shared decision-making. First steps will include:

- incorporating validated questionnaires for medicines review into the new PROMs platform including BPS Pain questionnaire, PHQ9, GAD 7 and the EQ-6D-5L
- creating a standalone web and mobile app to support pharmacogenomics decision making for four key drug classes.
- extending the current polypharmacy decision support integrated with primary care patient record systems to include patient-specific prompts and alerts for pharmacogenomics profiles.

#### 7.3 Shared decision aid for healthy weight management

Using an accelerator project grant award from Innovate UK, the RDS team has built a prototype of a shared decision-making toolkit to support people in identifying the healthy weight pathway best suited to their needs. We have held four productive consultation workshops to gather feedback and further suggestions and would value further input.
